## Installation

- Apply only to clean surfaces.
- MACHINE MIXING:
  - For each bag of Wall Mix-G, add approx 1 ¼ gallons of water .
  - After adding mixed Flex-C-Ment™ Modifier, add water until desired consistency is achieved
- HAND MIXING:
  - Empty bags into a suitable mixing container
  - For each bag of Wall Mix-G, add approx 1 ¼ gallons of mixed Flex-C-Ment™ Modifier
  - Work the mix with a shovel, rake or hoe and add water as needed until desired consistency is achieved
  - Be sure all material is wet
  - Do not leave standing puddles
