7. EQUIPMENT WILL ONLY BE RENTED WITH PROPER IDENTIFICATION AND A DEPOSIT OF AN OPEN SIGNED CHECK OR CREDIT CARD AUTHORIZATION FOR FULL REPLACEMENT VALUE OF THE EQUIPMENT.
8. IF EQUIPMENT IS NOT RETURNED THE OPEN CHECK WILL BE DEPOSITED OR THE CREDIT CARD CHARGED FOR THE FULL REPLACEMENT VALUE OF THE EQUIPMENT.
9. TO PAY FOR ALL TEXTURE MATS LOST, DESTROYED OR DAMAGED, AT FULL RETAIL, PLUS SHIPPING COSTS OF REPLACEMENT.
